COOPERATIVE ENDEAVOR AGREEMENT

This Cooperative Endeavor Agreement (the "Agreement") is made and entered into and is effective as of the date of the last signatory hereto, by and between:

CITY OF BATON ROUGE AND PARISH OF EAST BATON ROUGE, ("City-Parish"), represented herein by Sharon Weston Broome, Mayor-President, by virtue of a Resolution No. 54152 of the Metropolitan Council adopted March 13, 2019, and,

THE BRIDGE CENTER FOR HOPE, INC. ("The Bridge Center"), a Louisiana nonprofit corporation with its registered office located at 100 North Street, Suite 900, Baton Rouge, Louisiana 70802-5264, represented herein by Kathy Kliebert, its duly authorized Board Chair of said corporation.

The City-Parish and The Bridge Center are each individually referred to herein as a "Party" and collectively as the "Parties."

RECITALS

WHEREAS, The Bridge Center is a non-profit corporation authorized by and organized under the Laws of the State of Louisiana; and

WHEREAS, the governing authority of the City-Parish adopted Resolution 53687, attached as Exhibit A, on August 8, 2018 ("Resolution 53687") placing the matter on the December 8, 2018, ballot for the purposes of authorizing the levy and collection of a 1.5 mills ad valorem tax on the dollar of assessed valuation on all property subject to taxation within the boundaries of the Parish (the "Tax"), for a period of ten (10) years, commencing with the tax collection for the year 2019, and annually thereafter, to and including the year 2028, for the purpose of providing funds (after paying reasonable and necessary expenses of collecting and administering the Tax) to be used entirely and exclusively for the purpose of operating and maintaining a treatment center that will provide mental health and substance abuse services, and provide funds for adequate administrative and support staff in connection therewith; and

WHEREAS, the voters of East Baton Rouge Parish approved the proposition on December 8, 2018; and

WHEREAS, the governing authority of the City-Parish adopted Ordinance 16991 on February 13, 2019, authorizing the levy and collection of the Tax; and

WHEREAS, the proceeds of any ad valorem tax “shall constitute a trust fund to be used exclusively for the objects and purposes for which the tax was levied.” La. R.S. 39:704; and

WHEREAS, the CITY-PARISH and The Bridge Center are entering into this Agreement to evidence the obligations of the parties relative to the objects and purposes of the public funding of The Bridge Center from the proceeds of the Tax; and

WHEREAS, Article VII, §14(C) of the Louisiana Constitution of 1974, as amended (“La. Const. Art. VII, §14(C)”) provides that, for a public purpose, the State and its political subdivisions (including the CITY-PARISH) may engage in cooperative endeavors with each other, with the United States or its agencies, or with any public or private association, corporation or individuals; and

WHEREAS, the public purpose of this Agreement is to assign the use of public funds to The Bridge Center to manage the operation of a crisis stabilization program so as to accomplish the purposes of Resolution 53687 referred to above and as described in the Scope of Services attached hereto and incorporated herein by reference as Exhibit B during the term of the Agreement; and

WHEREAS, the City-Parish is granted the authority, pursuant to Article VII, Section 14(C) of the Louisiana Constitution, to enter into this Agreement, which shall require the use of City-Parish funds, provided legal requirements are met; and

WHEREAS, The Bridge Center was established to support the provision of comprehensive crisis stabilization services to individuals in crisis, many of whom have come into contact with law enforcement and would otherwise be taken to an emergency room or arrested and taken to jail; and

WHEREAS, The Bridge Center intends to manage the operation of a crisis stabilization program to be located in the Parish of East Baton Rouge, Louisiana and the Parties desire to memorialize the terms of such operation with this Agreement; and

WHEREAS, the City-Parish will provide certain funding to The Bridge Center for the operation of said crisis stabilization program; and

WHEREAS, The Bridge Center anticipates contracting with one or more appropriately licensed service providers to actually provide the services outlined in the Scope of Services and defined in Exhibit B during the term of this Agreement. It will be the responsibility and obligation of The Bridge Center to contract with, manage, and oversee the performance of said licensed service providers; and

NOW, THEREFORE, in order to consummate said understandings and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

AGREEMENT

ARTICLE I - OVERVIEW

- 1.1 Incorporation of Recitals and Exhibits. The foregoing Recitals constitute and are incorporated herein as substantive provisions of this Agreement. All Exhibits described herein are fully incorporated into and made a part of this Agreement by this reference for all purposes, regardless that one or more of them may not be attached to all versions or copies of this Agreement.
- 1.2 Purpose. The City-Parish and The Bridge Center hereby agree that The Bridge Center shall utilize the funds appropriated and delivered by the City-Parish to operate The Bridge Center according to the terms of this Agreement.
- 1.3 Authority. The City-Parish is granted the authority, pursuant to the Louisiana Constitution and the Plan of Government to enter into cooperative endeavor agreements with public and private persons for a public purpose, including agreements which may require the use of public funds. The City-Parish thereby enters into this Agreement to assign the use of public funds to The Bridge Center to manage the operation of a crisis stabilization program consistent with and to accomplish the purpose of Resolution 53687 and this Agreement and as described in the Scope and Services attached hereto and incorporated herein by reference as Exhibit B during the term of the Agreement.
- 1.4 Term. The term of this Agreement (the "Term") shall commence on March 13, 2019 (the "Commencement Date"), and end on December 31, 2029 (the "Termination Date"). The term of this Agreement may be extended by mutual consent of the Parties evidenced in writing signed by both Parties. Further, this Agreement may be terminated as set forth in Article 7 herein below.

ARTICLE 2 – CITY-PARISH FUNDING

- 2.1 Purpose of Funding. The Bridge Center shall be responsible for funding all costs associated with the operation of a crisis stabilization program as described in the Scope of Services attached hereto and incorporated herein by reference as Exhibit "B" during the term of the Agreement. The City-Parish shall make an annual appropriation to The Bridge Center, during the term of the Agreement to be used specifically to financially support the operation of The Bridge Center. For purposes of this Agreement, "Annual Appropriation" shall mean those funds specifically set aside by the City-Parish from the proceeds of the

Tax.

- 2.2 Determination of Annual Appropriation. For the first calendar year during the Term of this Agreement, in accordance with Generally Accepted Accounting Principles, the City-Parish will prepare a budget to reflect the anticipated revenues from the 2019 tax levy adopted by the Metropolitan Council for the period January 1, 2019 through December 31, 2019. For subsequent calendar years during the Term of this Agreement, The Bridge Center will prepare and submit an annual budget (the "Budget") to the Department of Finance for the City-Parish no later than July 31 for the City-Parish fiscal year beginning during the following calendar year and will be approved through the budgetary process provided for in the Plan of Government.
- 2.3 Payment of the Annual Appropriation. The Annual Appropriation shall be subject to Metropolitan Council approval and payable in monthly installments as collected no later than ten (10) days following receipt of the funds by the City-Parish during the Term of this Agreement.
- 2.4 Early Funding. Should the City-Parish elect to loan funds to The Bridge Center for operations to be conducted during calendar year 2019, The Bridge Center will provide to the Department of Finance for the City-Parish, for approval, a budget for such services no later than 45 days in advance of the funding of such loan.

ARTICLE 3 - REPRESENTATIONS AND WARRANTIES OF THE BRIDGE CENTER

- 3.1 The Bridge Center hereby represents and warrants to the City-Parish as follows:
 - 3.1.1 it is a non-profit corporation duly organized, validly existing and in good standing under the laws of the State of Louisiana, and is exempt from federal income taxation under section 501(a) of the Internal Revenue Code of 1986, as amended or the corresponding provisions of any future United States Internal Revenue Code (the "Code"), as an organization described in Code section 501(c)(3), and a publicly supported organization described in Code section 509(a)(1);
 - 3.1.2 it has the necessary power and authority to enter into, execute and deliver this Agreement and to recognize, incur and perform the obligations provided herein and to carry out and consummate all transactions contemplated in this Agreement;
 - 3.1.3 no consent or approval of any person or public authority or regulatory body is required as a condition to the validity or enforceability of this Agreement or, if required, the same has been duly obtained;
 - 3.1.4 this Agreement has been duly and properly authorized, executed and delivered by The Bridge Center, constitutes a valid and legally binding obligation of The Bridge

Center and is enforceable against The Bridge Center in accordance with its terms;

3.1.5 there are no proceedings pending or, to the knowledge of The Bridge Center, threatened, before any court or administrative agency which may affect the authority of The Bridge Center to enter into this Agreement;

3.1.6 the public purposes described herein are in furtherance of its purposes under the Code section 501(c)(3) and will not constitute an unrelated trade or business thereunder; and

3.1.7 that the Annual Appropriation will be used for operational purposes only.

3.2 Breach of Representations and Warranties. Promptly upon The Bridge Center becoming aware of the actual, impending or threatened occurrence of any event that would cause or constitute a breach, or would have caused or constituted a breach had such event occurred or been known to The Bridge Center prior to the date hereof, of any of The Bridge Center's representations and warranties contained in or referred to in this Agreement, The Bridge Center shall provide the City-Parish detailed written notice thereof and use its best efforts to prevent or to promptly remedy the same.

ARTICLE 4 – REPRESENTATIONS AND WARRANTIES OF THE CITY-PARISH

4.1 The City-Parish represents and warrants that:

4.1.1 it is a political subdivision of the State of Louisiana;

4.1.2 it has the necessary power and authority to enter into, execute and deliver this Agreement and to recognize, incur and perform the obligations provided herein and to carry out and consummate all transactions contemplated in this Agreement;

4.1.3 this Agreement has been duly and properly authorized, executed and delivered by the City-Parish, constitutes a valid and legally binding obligation of the City-Parish, and is enforceable against the City-Parish in accordance with its terms;

4.1.4 there are no proceedings pending or, to the knowledge of the City-Parish, threatened, before any court or administrative agency which may affect the authority of the City-Parish to enter into this Agreement.

4.2 Breach of Representations and Warranties. Promptly upon the City-Parish becoming aware of the actual, impending or threatened occurrence of any event that would cause or constitute a breach, or would have caused or constituted a breach had such event occurred or been known to the City-Parish prior to the date hereof, of any of the City-Parish's representations and warranties contained in or referred to in this Agreement, the City-

Parish shall provide The Bridge Center detailed written notice thereof and use its best efforts to prevent or to promptly remedy the same.

ARTICLE 5 - OBLIGATIONS OF THE BRIDGE CENTER

The Bridge Center agrees to do and perform each of the following:

- 5.1 authorize the Board Chair of The Bridge Center to execute and deliver this Agreement;
- 5.2 perform all obligations of The Bridge Center contained herein, including specifically, but not limited to, operating the Bridge Center and managing the operation of services provided through The Bridge Center according to the Scope of Services attached hereto and incorporated herein by reference as Exhibit "B;"
- 5.3 to provide the CITY-PARISH with an annual budget, in the ordinary course of business of the City-Parish in preparing its annual operations budget, which budget shall set forth in detail the lawful expenditure of the public funds anticipated to be collected, as well as all other funds provided to The Bridge Center;
- 5.4 to be fully responsible for any and all additional costs that exceed the public funds available or for which the expenditure of public funds are not lawful;
- 5.5 to provide the Office of the Mayor-President and the Metropolitan Council, through the Council Administrator, quarterly financial reports on March 31, June 30, September 30, and December 31 of each year, which reports shall include a listing of all public sources and use of those funds as well as a complete list of all paid (as opposed to volunteer) positions and salary for each position of those persons directly employed by The Bridge Center;
- 5.6 to conduct all board meetings in conformance with La. R.S. 42:11, et seq., the "Open Meetings Law";
- 5.7 to contract to provide annual external audits consistent with public accounting standards;
- 5.8 that all staff and board members shall be subject to and abide by the provisions of La. R.S. 42:1101, et seq., the Code of Governmental Ethics;
 - 5.8.1 to comply with the Louisiana Public Records Law (La. R.S. 44:1 et seq.) to the extent that The Bridge Center performs governmental functions and objectives, receives and disburses public funds, and/or uses public facilities or resources.
- 5.9 that a member of the Metropolitan Council be included on the board of directors, subject to normal nominating procedures as set forth in the Bylaws of The Bridge Center.

ARTICLE 6 – OBLIGATIONS OF THE CITY-PARISH

The City-Parish agrees to do and perform each of the following:

- 6.1. authorize the Mayor-President of the City-Parish to execute and deliver this Agreement;
- 6.2. perform all obligations of the City-Parish contained herein, including specifically, but not limited to, determining and paying the Annual Appropriation to The Bridge Center to financially support the operations of The Bridge Center;
- 6.3. to act as the taxing authority and to ensure that the objects and purposes for which the proceeds of the Tax are used and are consistent to those approved by the voters in the proposition approving the Tax.

ARTICLE 7 – TERMINATION AND TRANSITION

- 7.1 Termination by the City-Parish. The City-Parish may terminate this Agreement upon one hundred twenty (120) days' written notice to The Bridge Center in the following circumstances and subject to the following conditions:
 - 7.1.1 if The Bridge Center materially breaches this Agreement, however, if the breach is capable of being cured within forty five (45) days, and if the City-Parish has not previously notified The Bridge Center of the same or a substantially similar breach, then this right shall not be exercised unless and until The Bridge Center receives written notice of the breach from the City-Parish and fails to cure it within forty five (45) days of receiving notice;
 - 7.1.2 if The Bridge Center's selected operator, as managed by The Bridge Center, fails to maintain any license, accreditation, or certification required for its crisis stabilization program;
 - 7.1.3 if The Bridge Center ceases to qualify as a tax-exempt organization under Code section 501(c)(3);
 - 7.1.4 if The Bridge Center voluntarily initiates bankruptcy proceedings or becomes unable to pay its liabilities as and when they become due, or if involuntary bankruptcy proceedings are commenced against The Bridge Center and are not dismissed within ninety (90) days.
- 7.2 Termination by the Bridge Center. The Bridge Center may terminate this Agreement upon one hundred twenty (120) days written notice to the City-Parish in the following circumstances and upon the following conditions:

- 7.2.1 if the City-Parish materially breaches this Agreement or the Other Agreements, however, if the breach can be cured within forty-five (45) days, and if The Bridge Center has not previously notified the City-Parish of the same or a substantially similar breach, The Bridge Center shall not exercise this right unless and until the City-Parish receives written notice of the breach from The Bridge Center and fails to cure such breach within forty-five (45) days of receiving notice;
- 7.2.2 upon forty-five (45) days' written notice to the City-Parish upon a material change in law or applicable legal requirements affecting The Bridge Center's and/or the The Bridge Center's operations.

ARTICLE 8 – DISPUTE RESOLUTION

- 8.1 Informal Resolution. Any dispute between the Parties shall first be subject to informal resolution efforts between the senior management of The Bridge Center and the City-Parish. Any dispute that has failed to be resolved informally by the Parties within a reasonable period of time of the commencement of such discussions (not to exceed fifteen (15) days) may be referred to mediation as provided in Section 8.2, below.
- 8.2 Mediation. If the Parties are unable to reach agreement, they may mutually agree to jointly select a mediator, or, if the Parties are unable to agree on a mediator, one shall be selected by the Parish Attorney and the attorney for the Bridge Center. The goal of the mediation generally, and the specific task of the mediator will be to preserve the substance of the Agreement to the extent reasonably possible. The Parties will work in good faith with the mediator in an effort to reach a mutually satisfactory solution. In the event that the Parties are unable to reach a mutually satisfactory resolution to their dispute, either Party may resort to resolution of the dispute in accordance with Section 13.6 Governing Law and Venue, below.

ARTICLE 9 – FIDELITY BOND

The Bridge Center, at its sole expense, shall secure a fidelity bond to insure the City-Parish against any and all loss of funds or assets of the City-Parish provided pursuant to the Agreement due to misuse, mismanagement, and/or theft of such funds or assets by The Bridge Center, its officers, employees, agents, assigns or subcontractors. The amount of this bond shall be twenty-five percent (25%) of the Annual Appropriation provided under this Agreement.

ARTICLE 10 – AUDIT

- 10.1 Inspection and Audit of Records. For the term of this Agreement and for a period of three years following termination of this Agreement, upon providing five (5) business days' written notice to The Bridge Center, at any time during regular business hours, and as often

as the City-Parish may deem necessary, there shall be made available to the City-Parish for examination, The Bridge Center's records with respect to matters covered by this Agreement. The Bridge Center shall permit the City-Parish authorized representatives to audit, examine, and make excerpts or transcripts from such records, and to make audits of all contracts, invoices, materials, records of personnel, conditions of employment, and other data relating to matters covered by this Agreement. Any expenses associated with such inspection and audit of records shall be solely the responsibility of the City-Parish.

For the purposes of this agreement, "records" are extracts from all financial and related records (in whatever form they may be kept, whether written, electronic, or other) relating to or pertaining to this Agreement kept by or under the control of the Bridge Center, including, but not limited to those kept by employees, agents, assigns, successors, and subcontractors. Such records shall include, but not be limited to, accounting records, written policies and procedures; subcontract files (including proposals of successful and unsuccessful bidders, bid recaps, etc.); all paid vouchers including those for out-of-pocket expenses; other reimbursement supported by invoices; ledgers; cancelled checks; deposit slips; bank statements; journals; original estimates; estimating work sheets; contract amendments and change order files; logs and supporting documentation; insurance documents; payroll documents; timesheets; memoranda; and correspondence.

- 10.2 Repayment. The Bridge Center shall be responsible for repayment of any and all applicable audit exceptions, which may be identified by the City-Parish or their designated representatives and are material and adverse in nature to the City-Parish as to create an audit disallowance. The Bridge Center will be billed by the City-Parish for the amount of said audit disallowance and shall promptly repay such audit disallowance. In the event of such an audit disallowance, the City-Parish also may offset any current or subsequent monies due The Bridge Center from the City-Parish and pursue any other remedies under the law.
- 10.3 Audit. The City-Parish reserves the right to have an annual audit performed of The Bridge Center by an outside auditing firm. Any audit required under this section that is in addition to the annual audit requirement in Section 5.7 above shall be at the City-Parish's expense.
- 10.4 Expenditure Compliance with Budget and Government Agencies. The Bridge Center agrees that all expenditures are to be made in accordance with its Budget submitted to the City-Parish or any authorized amendments thereto.

ARTICLE 11 - RETENTION OF RECORDS

The Bridge Center shall maintain such records and accounts which support the services provided in this Agreement, for a period of three (3) years from termination of this Agreement, except where unresolved audit questions require retention for a longer period as determined by the City-Parish. These records shall be available during regular business hours, for audit purposes and inspection, to the City-Parish or any authorized representative of the City-Parish. If The Bridge Center should cease to exist, custody of all records related to this Agreement will be transferred to the City-Parish unless otherwise agreed to between the Parties.

ARTICLE 12 – REPORTS

It is the goal of The Bridge Center to maintain full transparency and accountability. At such times and in such forms as the City-Parish may reasonably require of The Bridge Center, The Bridge Center shall furnish to the City-Parish such statements, records, reports, data, and information as the City-Parish may request pertaining to the Annual Appropriation and any other matters covered by this Agreement.

ARTICLE 13 - MISCELLANEOUS

- 13.1 Survival of Warranties. All representations, warranties, agreements, covenants and obligations herein or in any schedule, certificate or financial statement delivered by any Party to any other Party incident to the transactions contemplated herein are material, shall be deemed to have been relied upon by the other Party, survive the Term as provided in Section 1.4 above regardless of any investigation and not merge in the performance of any obligation by any Party hereto.
- 13.2 Notices. Any notice, consent, report or demand required, permitted or desired to be given under or in connection with this Agreement by one Party to another Party shall be in writing and shall be either hand-delivered or deposited with the U.S. Postal Service, postage prepaid for delivery by first-class mail, registered or certified, return receipt requested, or by private, commercial carrier, such as Federal Express, or other similar form of rapid transmission where delivery is confirmed in writing by the addressee or by the delivery company. All communications shall be mailed, sent or delivered to the address set forth below, or as to each Party at another address as shall be designated in written notice to the other Party.

- 13.3 Entire Agreement. This Agreement constitutes the entire, full and final understanding between the Parties hereto and neither Party shall be bound by any representations, statements, promises or agreements not expressly set forth herein.
- 13.4 Assignability. The Bridge Center shall not assign this Agreement, except in writing and with the prior written approval of the Mayor-President, after authorization by the Metropolitan Council, which approval shall be subject to such conditions and provisions, as the City-Parish may deem necessary.
- 13.5 Confidentiality. Each Party shall maintain the security and confidentiality of all information that it receives from the other Party to the extent required and/or allowed by applicable laws and regulations.
- 13.6 Governing Law and Venue. This Agreement shall be governed by Louisiana law and venue for any action brought pursuant to this Agreement shall be appropriate in the Nineteenth Judicial District Court, Parish of East Baton Rouge, Louisiana.
- 13.7 Severability. Each provision of this Agreement shall be deemed to be a separate, severable, and independently enforceable provision(s). The invalidity or breach of any provision shall not cause the invalidity or breach of the remaining provisions or of the Agreement, which shall remain in full force and effect.
- 13.8 No Benefit to Third Parties. The Agreement is not intended to benefit, and shall not be

construed to benefit, any person or entities other than the Parties hereto or to create any third-party beneficiary right for any other person or entities.

- 13.9 Gender. Words of gender used in this Agreement may be construed to include any gender; words in the singular may include the plural of words, and vice versa.
- 13.10 Headings. Any heading of the paragraphs in this Agreement is inserted for convenience and reference only, and shall be disregarded in construing and/or interpreting this Agreement.
- 13.11 Copies. This Agreement may be executed in any number of copies and each such copy be deemed an original.
- 13.12 Waiver. The waiver of any term(s) of this Agreement, or the failure of the City-Parish to insist on strict compliance and prompt performance of any term(s) of this Agreement, followed by the acceptance of such performance thereafter, shall not constitute or be construed as a waiver or relinquishment of any right by the City-Parish to enforce all terms strictly in the event of a continuous or subsequent default.
- 13.13 Legal Authority. The signatory for The Bridge Center, below, certifies and warrants that The Bridge Center's name in this Agreement is the full legal name as designated in its corporate charter, that he/she is empowered to act and contract for The Bridge Center, and that this Agreement has been approved by the Board of Directors of The Bridge Center.
- 13.14 Interpretation. In the event of any question regarding the meaning of any of the provisions of this Agreement, the interpretation placed thereon by the City-Parish shall be final and binding on the Parties hereto, provided that any such interpretation shall not be unreasonable.
- 13.15 Amendment. Any and all modifications to the terms of this Agreement must be by a written Amendment, signed by the Parties and approved by the Metropolitan Council.
- 13.16 Independent Contractor. It is agreed by the Parties that at all times and for all purposes hereunder The Bridge Center is an independent contractor. Neither the City-Parish nor any of its departments, agents, or assigns shall have any responsibility for any acts or omissions of The Bridge Center, its employees, agents, or subcontractors. The Agreement shall not be construed as an employment contract and neither The Bridge Center nor any employees, agents or subcontractors shall receive benefits afforded by provisions or regulations governing classified or unclassified personnel for the City-Parish and The Bridge Center's representative by signature hereto expressly waive and relinquish any such rights.
- 13.17 Non-Discrimination.

- (a) The Bridge Center shall operate under this Agreement so that no person otherwise qualified is denied employment or other benefits on the grounds of race, gender, religion, national origin, sexual orientation, age, or disability or other unlawful forms of discrimination except where a particular occupation or position reasonably requires consideration of these attributes as an essential qualification for the position. The Bridge Center shall post in conspicuous places, available to employees and applicants for employment, notices setting forth the provisions of this nondiscrimination clause.
- (b) The Bridge Center shall not discriminate on the basis of race, gender, religion, national origin, sexual orientation, age, or disability or other unlawful forms of discrimination in the solicitation, selection, hiring, or treatment of subcontractors, vendors, suppliers, or commercial customers. The Bridge Center shall provide equal opportunity for subcontractors to participate in all of its public sector and private sector subcontracting opportunities. The Bridge Center understands and agrees that violation of this clause is a material breach of the contract and may result in contract termination, debarment, or other sanctions. This clause is not enforceable by or for the benefit of, and creates no obligation to, any third party.

13.18 Delay or Omission. No delay or omission in the exercise of any right or remedy accruing to any party hereto, upon any breach by any party hereto under this Agreement, shall impair such right or remedy or be construed as a waiver of any breach theretofore or thereafter occurring. The waiver of any condition or the breach of any term, covenant, or condition herein or therein contained shall not be deemed to be a waiver of any other condition or of any subsequent breach of the same or any other term, covenant or condition herein or therein contained.

13.19 No Personal Liability of the Bridge Center or City-Parish Officials. No covenant or agreement contained in this Agreement shall be deemed to be the covenant or agreement of any official, officer, agent or employee of any party hereto in his individual capacity and neither the officers of any party hereto nor any official executing this Agreement shall be liable personally with respect to this Agreement or be subject to any personal liability or accountability by reason of the execution and delivery of this Agreement except to the extent provided by law.

13.20 Compliance with Laws. The Bridge Center shall comply with all federal, state and local laws, ordinances, rules and regulations as well as applicable codes of ethics, pertaining to or regulating the provision of the services, including those now in effect and hereafter adopted. Any violation of such laws, ordinances, rules and regulations, and applicable codes of ethics shall constitute a material breach of this Agreement.

The Bridge Center agrees to abide by the requirements of the following as applicable: Title VI and VII of the Civil Rights Act of 1964, as amended by the Equal Opportunity Act of 1972, Federal Executive Order 11:246, the Federal Rehabilitation Act of 1973, as amended, the Vietnam Era Veteran's Readjustment Assistance Act of 1974, Title IX of the Education Amendments of 1972,

the Age Discrimination Act of 1972, and agrees to abide by the requirements of the Americans with Disabilities Act of 1990.

The Bridge Center agrees not to discriminate in its employment practices, and will render services under this contract without regard to race, color, religion, sex, national origin, veteran status, political affiliation, or disabilities.





That, subject to the approval of the State Bond Commission and under and pursuant to the authority conferred by Article VI, Section 30 of the Constitution of the State of Louisiana of 1974 (the "Constitution"), and the applicable provisions of Chapter 6 and Chapter 6-A of Title 18 of the Louisiana Revised Statutes of 1950, as amended, and other constitutional and statutory authority, an election be and the same is hereby called and ordered to be held in the Parish, on SATURDAY, DECEMBER 8, 2018, between the hours of six (6:00) o'clock a.m. and eight (8:00) o'clock p.m., in compliance with the provisions of Section 541 of Title 18 of the Louisiana Revised Statutes of 1950, as amended (La. R.S. 18:54), and that at the said election there shall be submitted to all registered voters qualified and entitled to vote at the said election under the Constitution and laws of the State of Louisiana and the Constitution of the United States of America, the following proposition, to-wit:

Shall the Parish of East Baton Rouge (the "Parish") be authorized to levy a 1.5 mills ad valorem tax on the dollar of assessed valuation on all property subject to taxation within the boundaries of the Parish (the "Tax") (an estimated \$6,000,000 is reasonably expected to be collected from the levy of the Tax for an entire year), for a period of ten (10) years, commencing with the year 2019, and annually thereafter, to and including the year 2028, and shall the proceeds of the Tax (after paying necessary expenses of collecting and administering the Tax) be used entirely and exclusively for the purpose of operating and maintaining a treatment center that will provide mental health and substance abuse services, and providing funds for adequate administrative and support staff in connection therewith?

SECTION 2. That conditioned on the passage of the 1.5 mills ad valorem tax at the December 8, 2018 election authorized pursuant to this Resolution, all avails or proceeds of said Tax (after paying the reasonable and necessary expenses of collecting and administering the Tax) shall be used entirely and exclusively for the purpose of operating and maintaining a treatment center that will provide mental health and substance abuse services, and providing funds for adequate administrative and support staff in connection therewith.

SECTION 3. That, in accordance with La. R.S. 18:1285, there shall be published in "*The Advocate*", a daily newspaper of general circulation within the Parish, published in the Parish, and being the official journal of the Parish, once a week for four (4) consecutive weeks, with the first publication to be made not less than forty-five (45) days nor more than ninety (90) days prior to the date fixed for election, notice of said election, which notice shall be substantially in accordance with the Notice of Election annexed hereto as Exhibit A and incorporated herein by reference the same as if it were set forth herein in full.

SECTION 4. That this Metropolitan Council, acting as the governing authority of the Parish, shall meet at its regular meeting place, the Council Chambers, City Hall, Third Floor, Room 348, 222 St. Louis Street, Baton Rouge, Louisiana, on WEDNESDAY, JANUARY 23, 2019, at FOUR (4:00) O'CLOCK P.M., and shall then and there in open and

public session proceed to examine and canvas the returns and declare the result of the said election.

SECTION 5. That the polling places set forth in the aforesaid Notice of Election and situated within the corporate limits of the Parish be and the same are hereby designated as the polling places at which to hold the said election in accordance with Section 1286(A) or Section 1286.1, as the case may be, of Title 18 of the Louisiana Revised Statutes of 1950, as amended, and the Commissioners-in-Charge and Commissioners, respectively, will be those persons designated according to law in accordance with Section 1286(A) or Section 1286.1, as the case may be, of Title 18 of the Louisiana Revised Statutes of 1950, as amended.

SECTION 6. That the officers designated to serve as Commissioners-in-Charge and Commissioners, respectively, pursuant to Section 5 hereof and in accordance with Section 1286(A) or Section 1286.1, as the case may be, of Title 18 of the Louisiana Revised Statutes of 1950, as amended, or such substitutes therefor as may be selected and designated in compliance with Section 1287 of Title 18 of the Louisiana Revised Statutes of 1950, as amended, shall hold the said election as herein provided, shall make due returns of said election for the meeting of the Metropolitan Council to be held on January 23, 2019, and that the compensation of said officers be and the same is hereby fixed at the sum prescribed by law. All registered voters in the Parish are entitled to vote at the said election and voting machines shall be used thereat.

SECTION 7. That the Council Administrator of this Metropolitan Council be and he is hereby empowered, authorized and directed to arrange for and to furnish to said election officers in ample time for the holding of said election the necessary equipment, forms and other paraphernalia essential to the proper holding of said election.

SECTION 8. That, in accordance with La. R.S. 18:1285(B)(1), certified copies of this Resolution shall be forwarded to the Secretary of State, the Commissioner of Elections, the Clerk of Court and Ex-Officio Parish Custodian of Voting Machines in and for the Parish, and the Registrar of Voters in and for the Parish, as notification of the election herein called in order that each may prepare for said election and perform their respective functions as required by law.

SECTION 9. That application be and the same is hereby formally authorized to be made to the State Bond Commission for consent and authority to hold the aforesaid election as herein provided, and that a certified copy of this Resolution shall be forwarded to the State Bond Commission on behalf of this Metropolitan Council, together with a letter requesting the prompt consideration and approval of said application.

A resolution approving the issuance, sale and delivery of the Not to Exceed \$320,000 Revenue Bond, Series 2018, of the Chaneyville Fire Protection District No. 7 of the Parish of East Baton Rouge, State of Louisiana; and other matters relating thereto.

In compliance with the provisions of Article VI, Section 15 of the Louisiana Constitution of 1974, as amended, and in accordance with the request of the Board of Commissioners of Chaneyville Fire Protection District No. 7 of the Parish of East Baton Rouge, State of Louisiana, this Metropolitan Council hereby approves the issuance, sale and delivery of the Not to Exceed \$320,000 Revenue Bond, Series 2018, of said District in accordance with a duly adopted resolution of the Board of Commissioners of said District. The Indebtedness shall be secured by and payable solely from a pledge and dedication of the avails or proceeds of the ten (10) mills ad valorem tax levied by the District for a period of ten (10) years, commencing in the year 2018, and annually thereafter, to and including the year 2027, and approved by the voters in the District on November 18, 2017, and neither the Parish of East Baton Rouge, the City of Baton Rouge, nor this Metropolitan Council shall in any way be liable for the payment of the principal of and/or interest on the Indebtedness.

EXHIBIT "B"

SCOPE OF SERVICES TO BE PROVIDED BY THE BRIDGE CENTER FOR HOPE

1. The Bridge Center Mobile Assessment Team

The Bridge Center will manage the operation of a Mobile Assessment Team (MAT) that will be available to respond to calls primarily from law enforcement, specifically CIT-trained officers, and over time, as available, to the Parish Prison. The MAT will be staffed in accordance with Louisiana licensing standards and, where a license does not exist, industry norms, and will be available by phone and able to respond to law enforcement 24 hours a day, 7 days per week. The goal is to have the MAT available to respond to calls and complete an in-person assessment, if indicated, within minutes.

2. The Bridge Center Crisis Assessment Center

At The Bridge Center, careful consideration will be given for how clients are taken into the facility, as ultimately some will be coming to the center voluntarily and others involuntarily. Triage will see patients in any intake scenario, whereby they will provide a health screening to ensure they can be treated at The Bridge Center and, if they can, determine which bed and services are most appropriate.

3. The Bridge Center Sobering Beds

The Bridge Center will manage the operation of sobering beds designed to provide a safe place to rest for people under the influence of alcohol and/or drugs. The Sobering Unit will be staffed in accordance with Louisiana licensing standards and, where a license does not exist, industry norms. Expected length of stay is less than 12 hours.

4. The Bridge Center Detox

The Bridge Center will manage or coordinate with other service providers the operation of a Detox program designed to provide a set of interventions (evaluation, stabilization, referral to community treatment) and manage acute intoxication and safe withdrawal from substances. The goal is to minimize physical harm the individual might experience as a result of substance dependence and to identify needed resources for ongoing care post-medical detox. The typical length of stay will be determined by substance dependence severity and the substances used and the expected length of stay will be between 4 and 10 days. The Detox program will be staffed in accordance with Louisiana licensing standards and, where a license does not exist, industry norms.

5. The Bridge Center Behavioral Health Respite

The Bridge Center will manage the operation of a Behavioral Health Respite program designed to serve people experiencing a behavioral health crisis. The program will be staffed in accordance with Louisiana licensing standards and, where a license does not exist, industry norms. The typical length of stay will be between 23 and 72 hours.

6. The Bridge Center Care Management Team

The Bridge Center will manage the operation of a Care Management Team (CMT) designed to coordinate care and provide direct services within the community. The team will be staffed in accordance with Louisiana licensing standards and, where a license does not exist, industry norms.
